1. I accept for use (and any minor child) equipment provided through The Nature Connection and Delta County Libraries and accept full responsibility for the care of the equipment while it is in the possession of myself or my child. I have examined the equipment and accept it as is.
2. I understand that there are inherent and other risks involved in the sport of snowshoeing, for which this equipment is to be used, that injuries are a common and ordinary occurrence of the sport, and I freely and voluntarily assume those risks on behalf of my child and for myself.
3. I agree, for myself and my minor child using the equipment, to hold harmless and indemnify The Nature Connection and Delta County Libraries, and their boards, coaches, agents and employees for any loss or damage, including any that result from claims for personal injury, death or property damage to me, any minor child of mine or third party, related to the use of the equipment furnished by The Nature Connection and Delta County Libraries.

4. For both myself and my minor child using the equipment, I hereby release from any legal liability the United States Forest Service, Delta County Libraries, The Nature Connection and their boards, coaches, agents and employees for damage, injury or death to myself, to my minor child, or to any other person resulting from selection, installation, maintenance, adjustment or use of the equipment or trails and for any claim based upon negligence, breach of warranty, contract or other legal theory, accepting for myself the full responsibility for any such damage, injury, or death which may result.
  
5. This agreement is governed by the applicable laws of the State of Colorado. If any part of this agreement is determined to be unenforceable, all other parts shall be given full force and effect.
  
6. I agree that any losses or damages beyond normal wear and tear will be paid for according to the damaged and lost equipment fee chart (below). I also agree that I will pay a \$10.00 late fee per pair of snowshoes and per pair of poles per day past the due date.

**Late, Damaged or Lost Equipment Fees**

A Cedaredge Library staff member will inspect and confirm that the gear is in working order before lending it. Below are the fees for late, damaged or lost equipment.

Late poles	\$10 per day
Late snowshoes	\$10 per day
Broken / damaged pole(s)	\$15.00 per pair
Broken / damaged snowshoe(s)	\$30.00 per pair
Lost poles	\$30.00 per pair
Lost snowshoes	\$60.00 per pair
